Parent & Player Participation Agreement:

We understand our daughter's participation in this program requires our commitment and support. We commit to having our daughter to practices and tournaments on time. We commit to communicate with the coach prior to practices and tournaments if we will be unable to attend. We commit to support and encourage our own daughter and the club as a whole.

We commit to pay any fees due on time. We understand by not paying all fees and monies in full and on time, our player will be suspended from games and practices until all fees and monies are brought current, including late fees. We understand that we will be charged a drop out fee of \$100 if we decide to stop playing before the final payment is due.

We agree to support our coach, even when we do not agree with their decisions. We agree that our coach has the last and final say on play time and positions. We will refrain from sideline coaching and referring during games as this can confuse and distract players and shows disrespect for the coach and the referees. We understand that if we do have a disagreement with the coach, we will discuss it in a time, place and manner that are appropriate. The court around game time and around other teams is not appropriate. We also understand that we will discuss any topic with the coach that could affect the team prior to discussing it with other parents.

We understand that a lot is expected out of our daughter while practicing and playing with the team. She should display proper attitude and good sportsmanship at all times. Foul or vulgar language will not be tolerated. She should always hustle and do her best. She should maintain a 2.0 GPA or better as this is required for participation in high school sports and for scholarships.

We understand that we may be called upon to assist with the team/club during the season. We agree to cooperate and do our fair share. We understand that we may purchase items for the team outside of what is offered by the club, but these purchases must be approved by the board.

We agree to allow YVC to use any photo of our daughter taken during a club event to be used on the club website and on any print material without any further consent or compensation due.

By signing this agreement, we agree to abide by all items above and understand that any violations of the above will result in removal from the club. We also understand that there will be no refund of monies already paid.

At least one parent or legal guardian and the player must sign the agreement. The parent or legal guardian so signing the agreement is binding the other to this agreement also.
